Grants & Donations

The Council operates a grant system for the benefit of local groups which may apply for grant funding to carry out work for the benefit of members of the community within the electoral boundary of St Harmon and Pant y Dwr.

The grants application system is open throughout the year. Applications must be submitted in writing to the Clerk containing as much information as possible. The council has a limited budget allocation.

Bryn Titli Fund (Wind Farm)

The Council is awarded a sum of money annually from the Bryn Titli Wind Farm project. This is for allocation to community groups and community projects. The Community Council manages this fund and allocations are made under 2 separate processes: Grant Funding and Community benefit Purchases/Allocations.

Grant Funding

This is managed in two phases

Budget Monitoring

The Council is presented with a bank reconciliation report at each meeting which enables members to be kept up to date with council finances.

The Community Council is committed to using local contractors and suppliers wherever possible and believes in the value of the "Powys Pound."

Council Financial Reserves

The Council holds financial reserves some of which are held within individual budget headings and others are held within general reserves. It is crucial the Council holds sufficient reserves to maintain its operation effectively and in preparation for future projects and services. A full list of financial reserves is provided to members at the end of each financial year (1st April.) These are also reported via the external audit process.

Audit Wales Investigation

The Community Council was under investigation by Audit Wales based on the 2018/19 annual return. Following the outcome the council received an invoice £16335 which has been fully settled in the financial year 2022/23. This has debt has now been fully discharged

Council Members Code of Conduct

The Council had reported former Councillor Sheila Jenkins to the Public Services Ombudsman for a perceived breach of the Code of Conduct. The following result was published on the Ombudsman's website – "Our report concerned a complaint that the Former Councillor had failed to declare personal and prejudicial interests at two Council meetings. Adjudication Panel for Wales decided that the Councillor should be disqualified for 12 months."

Projects

During 2022/23 the Council worked on the following projects:

- Tree planting via Woodland Trust Project on the Recreation Field
- Promotion of a Community Broadband Scheme in partnership with Broadway Partners.
- Development of increased Community Engagement
- Working on partnership with local residents and the Community Hall to facilitate community events, which included the Queen's Platinum Jubilee.
- Held a stand at the Community Show to promote the work of the Community Council and provide information to local residents. This was an extremely successful day.
- Installation of speed warning signs throughout the community to discourage speeding.
